Dear Ms. Repajic:

On January 19, 2012, pursuant to Health and Safety Code section (HSC) 34169 (g) (1), the City of Chino Redevelopment Agency, for which you are now the Successor, submitted an adopted Enforceable Obligation Payment Schedule (EOPS) to the California Department of Finance (Finance). Finance recently contacted you to get further clarification for items listed in the EOPS.

HSC section 34171 (d) lists characteristics of obligations considered enforceable. Based on our interpretation of the law, the following do not qualify as Enforceable Obligations.

- Line items 1 through 16 on page 2 (shown on attached worksheet) for city loans totaling \$16 million. HSC section 34171 (d) (2) states that agreements, contracts, or arrangements between the city that created the redevelopment agency (RDA) and the former RDA are not enforceable unless the loan agreements were entered into within the first two years of the date of the creation of the RDA.
- Line items 6 through 11 on page 4 (shown on attached worksheet) for contracts totaling \$33.8 million. HSC section 34163 (b) prohibits a RDA from entering into contracts with any entity after June 29, 2011. It is our understanding that binding construction contracts for these projects have not yet been awarded.

Finance recognizes our timeframe to review the EOPS has lapsed. However, should these items be on the Recognized Obligation Payment Schedule (ROPS) that is adopted by your Oversight Board, we will return the ROPS for reconsideration. This action will cause the ROPS to be ineffective until Finance approval and may cause payment delays for valid obligations.

If you believe we have reached this conclusion in error, please provide further evidence that the items questioned above meet the definition of an Enforceable Obligation.
