Re: Notification of Adoption and Posting, by the Successor Agency to the former Redevelopment Agency of the City of Redlands, of a Revised Enforceable Obligation Payment Schedule With Reservations

Dear Ms. Doyle:

This letter serves as formal notification that the Successor Agency to the former Redevelopment Agency of the City of Redlands (the "Successor Agency") at a meeting held of April 17, 2012, approved and adopted a revised Enforceable Obligation Payment Schedule containing all the obligations which the Successor Agency has determined are enforceable obligations of the former Redevelopment Agency from January through June 2012 pursuant to Health and Safety Code Sections 34167 and 34169, and reserving the right to challenge the legality of all or any portion of AB X1 26 through administrative or judicial proceedings. Attached is a copy of the revised Enforceable Obligation Payment Schedule. A copy of the revised Enforceable Obligation Payment Schedule can also be found on the City's website at www.cityofredlands.org.

Please also be advised that the Oversight Board of the Successor Agency to the former Redevelopment Agency of the City of Redlands (the "Oversight Board"), at a special meeting held of April 12, 2012, approved by a vote of 5-0-0 (with two board members not in attendance) the revised Enforceable Obligation Payment Schedule and also approved by vote of 5-0-0 a Recognized Obligation Payment Schedule listing outstanding obligations of the former Redevelopment Agency of the City of Redlands from January through June 2012 (the "ROPS"). The ROPS shall replace the revised Enforceable Obligation Payment Schedule once the ROPS is approved by the Department of Finance and certified by the Auditor-Controller/Treasurer/Tax Collector of San Bernardino County.
