Adopt **Resolution No. 2023-22** approving the Successor Agency to the Redevelopment Agency of the City of Upland's Last and Final Recognized Obligation Payment Schedule for the Period July 1, 2024 through June 30, 2037.

BACKGROUND INFORMATION

Pursuant to California Health and Safety Code ("HSC") section 34191.6 (a), beginning January 1, 2016, successor agencies may submit a Last and Final Recognized Obligation Payment Schedule if all the following conditions are met:

- The remaining debt is limited to administrative costs and payments pursuant to enforceable obligations with defined payment schedules including, but not limited to, debt service, loan agreements, and contracts.
- All remaining obligations have been previously listed on the ROPS and approved for payment by the Department of Finance pursuant to HSC section 34177 (m) or (o).
- The successor agency is not a party to outstanding/unresolved litigation.

The Successor Agency to the Redevelopment Agency of the City of Upland ("Upland Successor Agency") meets all of the above conditions required to submit a Last and Final ROPS ("LFROPS") request to the Countywide Oversight Board for approval and submission to the State Department of Finance ("DOF").

The remaining debt items for the Upland Successor Agency include annual bond debt service payments for its 2016 Tax Allocation Refunding Bonds (the "2016 Bonds"), annual bond Trustee fees for the 2016 Bonds, annual disclosure and arbitrage reporting fees related to the 2016 Bonds, and an annual administrative allowance for the Successor Agency (the Successor Agency's currently outstanding 2013 Tax Allocation Refunding Bonds will be retired on September 1, 2023).

The Successor Agency has a current approved annual ROPS for FY 2023-24. Upon approval by DOF, the proposed LFROPS will cover all remaining obligations of the Successor Agency for the period of July 1, 2024 through June 30, 2037. The total requested funding on the proposed LFROPS is \$12,764,364, including \$14,100 per year for administrative expenses (currently, the annual ROPS for FY 2023-24 includes approved annual administrative expenses for the Successor Agency in the amount of \$195,000).

Resolution Approving the Successor Agency to the Redevelopment Agency of the City of Upland's Last and Final Recognized Obligation Payment Schedule for the Period of July 1, 2024 through June 30, 2037. September 14, 2023

The recommended action will further the Upland Successor Agency's dissolution as part of the wind-down of the Upland Successor Agency.

It is recommended the CWOB approve the Upland Successor Agency's LFROPS for the period of July 1, 2024 through June 30, 2037. Pursuant to HSC 34191.6(b), the Oversight Board-approved LFROPS shall be sent to the county administrative officer, county auditor-controller, and posted to the successor agency's website at the same time that the LFROPS is presented to DOF for review. Pursuant to HSC 34191.6(c), DOF will have 100 days to review the LFROPS.

RESOLUTION OF THE SAN BERNARDINO COUNTYWIDE OVERSIGHT BOARD APPROVING THE SUCCESSOR AGENCY TO THE REDEVELOPMENT AGENCY OF THE CITY OF UPLAND'S LAST AND FINAL RECOGNIZED OBLIGATION PAYMENT SCHEDULE FOR THE PERIOD OF JULY 1, 2024 THROUGH JUNE 30, 2037

On Thursday, September 14, 2023 on motion of San Bernardino Countywide Oversight Board Member Warren, duly seconded by San Bernardino Countywide Oversight Board Member DeNava and carried, the following resolution is adopted by the San Bernardino Countywide Oversight Board, State of California.

WHEREAS, California Health and Safety Code (HSC) section 34179(e) requires all action items of the San Bernardino Countywide Oversight Board be accomplished by resolution; and

WHEREAS, pursuant to HSC section 34191.6(a), the Successor Agency to the Redevelopment Agency of the City of Upland ("Upland Successor Agency") may prepare a proposed Last and Final Recognized Obligation Payment Schedule ("LFROPS") and submit such proposed LFROPS to the Countywide Oversight Board ("Oversight Board") for approval if certain conditions are met; and

WHEREAS, Upland Successor Agency has met the conditions set by HSC section 34191.6 (a); and

WHEREAS, pursuant to HSC section 34191.6(b), the Upland Successor Agency may then submit the Oversight Board-approved LFROPS to the State Department of Finance ("DOF") for review and approval. A copy of the Oversight Board-approved LFROPS must also be submitted to the County Administrative Officer, the County Auditor-Controller, and posted to the Upland Successor Agency's internet website; and

WHEREAS, pursuant to HSC section 34191.6(c), DOF shall have 100 days to review the LFROPS submitted pursuant to subdivision (b).

NOW, THEREFORE, the San Bernardino Countywide Oversight Board hereby resolves, determines and orders as follows:

Section 1. The foregoing recitals are true and correct.

Section 2. The Upland Successor Agency's LFROPS for the period of July 1, 2024 through June 30, 2037 in the form presented in Attachment "B", attached hereto and incorporated herein by this reference, together with such changes thereto as may be approved by the San Bernardino Countywide Oversight Board, is hereby approved.

Section 3. The LFROPS for the period of July 1, 2024 through June 30, 2037 in the form presented in Attachment "B" shall be transmitted to DOF, with copies submitted concurrently to the County Administrative Officer, County Auditor-Controller, and posted to the website of the Upland Successor Agency (City of Upland).

Section 4. This resolution shall take effect from and after the date of its passage and adoption.
